**These fees, payments and sums were approved at a Meeting of the Parish Council held on 5<sup>th</sup> June 2023 and ratified by them. These fees will come into operation as from 1<sup>st</sup> July 2023.**

## **EXUMATIONS**

In the event of an Exhumation being ordered by a Magistrate or a Coroner and undertaken with the sanction of the Police, a fee equivalent to a similar Interment shall be charged.

In the event of a Re-Interment, the suitable Interment fee shall also be charged.

## **RULES**

The fees indicated for the various headings:-

- (a) do not include the digging of the grave (Rule 12)
- (b) apply provided that the interment is made within 15 minutes of the time arranged with the Sexton. If not so made an additional £2.00 is payable in respect of each 15 minutes after that time(Rule 4)
