

# MINUTES OF THE PARISH COUNCIL MEETING HELD ON MONDAY 7<sup>th</sup> April 2025 AT CHADDESLEY CORBETT VILLAGE HALL AT 7:00 pm

- 1. **APOLOGIES**: Cllrs S Smith and C Finnegan
- 2. Police Report: 0275\_I\_19032025 Theft Bromsgrove Road A grass topper mower and an anvil have been stolen from a farm, overnight between 18<sup>th</sup> and 19<sup>th</sup> March. No buildings were entered.
  - Attempt Theft Fox Lane, Chaddesley offenders broke a lock on a shed in this location but did not gain entry. This happened sometime between 16 18th March. Its is believed that offenders came across a field to gain access onto the property.

## 7. Councillor's Reports

7.1 **District Councillors Reports** – Cllr Marcus Hart reported the following: We have been dealing with the usual routine casework, reporting litter and fly tipping on the main A roads and along the country lanes and continue to monitor all enforcement issues. # 7.1.1 **County Councillors Report** – Cllr Marcus Hart the following:

As you will all no doubt have seen, work on the new pavement for the A448 is well under way. There have been several night closures so far. They are ahead of schedule and should finish in the next couple of weeks They were marking out last week. The pavement right from Winterfold on the A448 has been reported for siding out in places where there is debris and is too narrow. I am very pleased to say that all of the pavement from Chaddesley Village to Lower Chaddesley has been sided out which has made the pavement circa 2 feet wider and much safer to walk along. The worn out kerbs will all be replaced but this will require a much bigger scheme of work and need to be done under traffic management and so I will get a date for that when I am able. # 7.3 Councillors' Reports -

- 7.3.1 Cllr D Newbould reported that two pictures were purchased on behalf of the Parish Council, funded by an anonymous benefactor. The Village Hall Committee has agreed to display them in the Village Hall. The artworks were featured in the Susan Shaw exhibition at Rowberry's.
- 7.3.2 Cllr H Grove reported that a meeting with the planners and the Light Pollution Working Group is scheduled for 22nd April.
- 7.3.3 Cllr M Page highlighted the value of CALC as a key support body for the Parish Council and encouraged members to attend meetings or join the group. The Clerk added that anyone interested in meetings or training should contact her to be booked on.
- 7.3.4 On behalf of Cllr S Smith, Cllr M Page gave a brief update on the LNRS Working Group. He highlighted recent activities at the allotments, including planting sessions with school children and educational talks on composting and nature. A follow up visit is planned for July so the children can see the crops growing.
- 7.3.5 Cllr M Page highlighted the upcoming Movies at Chaddesley film festival, which will mark the group's 10th anniversary and celebrate 200 years of passenger railways. The event will feature films, talks, and walks in partnership with the History Society. He also noted that the committee is seeking new members to help continue the group's work and support future events.

#### 7.4 Clerk's Report

- 7.4.1 A report has been submitted to Highways regarding the trees along the A450.
- 7.4.2. A few days ago, I was approached about the possibility of placing bleed kits with the defibrillators. I will provide an update once I receive more information.

### 8. CHADDESLEY CORBETT MATTERS FOR DISCUSSION OR DECISION

8.1 **Purchase of the Allotment update** – Cllr D Newbould provided an update: We are disappointed to report that the Land Registry has been unable to grant title to the Diocese. As a result, the Diocese has been unable to register the land, which means the



Parish Council cannot proceed with the purchase. Therefore, the Levelling Up grant funding has now expired, and the £60,000.00 will be returned to the grant providers. The National Lottery Fund has also been informed.

- 8.2 **Finance Committee** Cllr D Thomas reported that the end of year accounts meeting had taken place. The committee reviewed the documents, confirmed their accuracy and approved them. The Clerk will now proceed with submitting the paperwork and AGAR to the internal auditor.
- 8.3 **Update from Emergency Recovery Strategy Working Group** Work on the Community Emergency document is ongoing. Most rural councils, including ours, rely on Wyre Forest's emergency plan. Discussions are underway about using the Village Hall as an emergency hub, with plans to meet a hire company regarding generators.
